Subject : Urgent requirement of medical liquid Oxygen.

Respected Sir,

As already informed vide our earlier letter dated 22.04.2021 Kailash Group of Hospitals, at its various locations in district Gautam Buddha Nagar, is catering to over 600 oxygen dependent Covid Patients. Our hospitals are facing acute shortage of oxygen and patients are in urgent need of it. We have been trying our best but are unable to meet high demand of oxygen due to spike in Covid cases.

We have oxygen left for 4-5 hours and the patients need oxygen for survival.

We reiterate that we admit only those Covid patients whose oxygen saturation level is less than 85% to 90%.

Needless to say that we will follow the instructions issued by your office regarding admission of patients.

It is, therefore, requested to arrange oxygen on urgent basis for maintaining the operations.

Further if oxygen, beyond our present requirement, is made available to us we shall be able to serve around 200 additional oxygen dependent Covid patients.
